## 個人資料蒐集、處理及利用同意書

### Personal Data Collection, Processing and Use Agreement

國家表演藝術中心（附設國家交響樂團，以下簡稱本樂團）為蒐集、處理、利用個人資料，依個人資料保護法之規定以本聲明及同意書向您行書面告知並徵求您同意。當您於頁末簽名處簽署本同意書時，表示您已閱讀、瞭解並同意接受本同意書之所有內容。

According to the Personal Data Protection Act, National Performing Arts Center (National Symphony Orchestra/ Taiwan Philharmonic, hereinafter as NSO) issues its statement of personal data protection and collection agreement to notify you of your responsibilities and rights and solicit your consent to the collection, processing and use of your personal data by NSO. Your signature below indicates that you have read, understood and accepted the contents set forth in this agreement.

#### 一、個人資料之蒐集、更新及保管

- (一)本樂團係依據中華民國「個人資料保護法」與相關法令之規範，蒐集、處理及利用您的個人資料。
- (二)請提供您本人正確、最新及完整的個人資料。

  - 4.請求停止蒐集、處理或利用。
  - 5.請求刪除。

您行使上述權利，而導致權益受損時，本樂團將不負相關賠償責任。

#### I. Personal Data Collection, Renewal and Management

- (A)NSO will collect, process, and use your personal data in accordance with the Personal Data Protection Act, and relevant laws and rules enacted in the Republic of China.
- (B)Please provide your accurate, latest and complete personal data.
- (C)Your personal data collected by NSO to facilitate its administration includes the name, the number of personal ID card or resident certificate, contact information (including but not limited to phone number, email address, residential or work address), financial institution's account, and any other information that directly or indirectly identifies you.
